**SUBJECT: CONDUCT OF STUDENTS INSIDE AND OUTSIDE THE UNIVERSITY**

---

This is to bring to the attention of all Machakos University students that some students are conducting themselves inappropriately inside and outside the Machakos University. Some students have in the recent past conducted themselves in a manner likely to breach University Rules and Regulations governing the conduct and discipline of students at Machakos University Schedule IX as stipulated in the University statutes. In particular, the University Management is very concerned that some students force their way through the University main gate without showing their identity cards, or even without explaining why they don't have their identity cards. Showing identity cards to the University security guards is for the good of all students and staff of the University. Security of both students and staff is paramount to the University Management.

Additionally:

1. It has been noted with concern that some students don't respect and adhere to the administrative and academic procedures contrary to clause 15(1) (b) of the Machakos University Statutes.
2. Some students don't respect the rights and privileges of other students and members of the University community all the time, contrary to clause 15 (1) (b) of the University Statutes.

3. Some students don't carry themselves in all public fora or places with such humility and dignity as befits their status as mature and responsible citizens, contrary to clause 15(1) (d) of the University Statutes.

4. A few students cannot refrain themselves from creating noise that may cause disturbance and annoyance to the University community, contrary to clause 15 (1) (k).

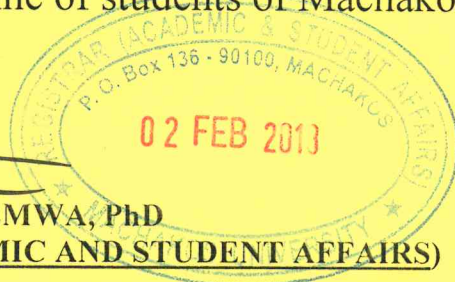

5. No student is allowed to assault another student or any member of staff discharging office duties. Assaulting a fellow student or a member of staff discharging duty is contrary to clause 11(17) (b) (iii) of the University Statutes. This is a reminder to all students that any student contravening any of the above rules and regulations governing the conduct and discipline of students may:

i) be suspended from Machakos University immediately;

ii) face disciplinary action; and

iii) be discontinued from Machakos University on account of indiscipline.
