## NOTICE!!ELECTION

In accordance with the provisions of the Retirement Benefits (RB) Act and Regulations, Notice is hereby given for member Trustees election which shall be conducted on **1**<sup>st</sup> **November 2019.** The structure of the Machakos University Staff Retirement Benefits Scheme requires at least one half of the Board of Trustees to be elected by members. Further, Trustees serve a renewable term of 3 years but limited to a maximum of two terms.

This is therefore to inform all members that **three (3)** positions of elected trustees will fall vacant 4<sup>th</sup> November 2019. The vacant positions are of **two (2) teaching/ academic** and **one (1) non-teaching**.

The entire election process will be managed by the trustees' election committee in liaison with the administrator:

## 1. Election of candidates - Eligibility conditions

A person is eligible for election as a member-nominated Trustee if;

- a) He/she is a member of the Scheme
- b) Has never been disqualified to act as a trustee by the Retirement Benefits Authority.
- c) Has never been declared bankrupt.
- d) Has never been convicted of any crime relating to dishonesty.
- e) Is of sound mind
- f) He/She will always be available to fulfill duties as a Trustee which includes attending Trustee meetings
- g) Possess a current certificate of good conduct
- h) Possess current clearance certificate from Credit Reference Bureau (CRB)

### 2. Qualities and Responsibilities of a Trustee

To assist you in making your nominations we summarize below the qualities and responsibilities of a trustee:

- **a)** To act jointly with the other Trustees.
- **b)** To understand and comply with the provisions of the Trust Deed and Rules.
- c) To understand and oversee the implementation of appropriate investment strategies for the Fund.
- **d)** To take part in the selection of competent service providers and oversee their performance.
- **e)** To understand how to safeguard the schemes assets.
- **f)** To act with impartiality in respect of all members and beneficiaries.
- g) To understand how the scheme should be administered in accordance with the RBA Act.
- **h)** To act with due care, diligence and good faith.



i) To understand the regulatory environment and oversee compliance with the regulations.

The Trustees must therefore, have a clear understanding of the goals of the Scheme and how they need to be achieved.

Kindly note: All trustees are required to attend a compulsory training at College of Insurance: Trustee Development Program Kenya (TDPK)

Eligible candidates willing to be elected are required to submit the following to the Election Committee Chairperson at the Pensions Office on or before **3**<sup>rd</sup> **October 2019.** (Soft copies can be sent to the scheme's email)

- a. Application Letter (Typed and signed)
- b. Updated CV
- c. Colored passports
- d. Copy of current Certificate of good conduct
- e. Copy of current clearance certificate from CRB
- f. Duly filled election member nomination form (Collected at the pensions office, filled and signed by at least 10 pension/ scheme members)
